Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the form in Federal Acquisition Regulation (FAR) subpart 12.5, Standard Procurement Procedures for Evaluation and Selection for Commercial Items, as supplemented in this announcement. This announcement contains the only solicitation; quotations are being requested, and a separate request for solicitation documentation will not be issued.

The association North American Industrial Classification System (NAICS) code for this procurement is 541330, which is a small business size standard of \$15 million.

The Program Contracting Activity (PCA) is seeking the services of a qualified vendor or provider on-site Construction Manager for the purposes of taking care of day-to-day oversight work for the project, technical assistance from CM/Cx-O firm for design reviews, occasional site inspections, and a series of reviews for project documentation and commissioning reports, physical inspections, and task-level technical analysis and reporting.
